## DAYSTAR PETROLEUM, INC.'S, REPLY TO MOTION FOR EXPEDITED HEARING ON APPLICATION

COMES NOW, Daystar Petroleum, Inc., ("Daystar") and in reply to the Motion of Keith F. Walker Oil & Gas Co., LLC, ("Keith FI Walker") for Expedited Hearing on Application, states, alleges and avers as follows:

- Daystar requested the Commission set this matter for hearing on July 17,
   2008, in order to provide for reasonable time for discovery and for a pre-hearing conference in this matter.
