ORDER NUNC PRO TUNC

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On July 26, 2018, the Commission issued an Order Adopting Audit Report in this Docket. The Order adopted Audit Report Finding No. 2 as recommended by the KUSF Administrator, GVNW Consulting, Inc. (GVNW). Audit Report Finding No. 2 identified a KUSF underpayment stemming from not reporting revenue received from the federal Lifeline program by Tempo Telecom, LLC (Tempo) for the period from July 2016 to March 2018. The KUSF underpayment was \$3,810.16.
- 2. The Order Adopting the Audit Report in paragraph B incorrectly stated that the underpayment was \$2,508.00 rather than \$3,810.16. To correct this error, the amount stated in paragraph B should be \$3,810.16 in the proclamation at the end of the Order.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. To correct the error contained in paragraph B of the Order Adopting Audit Report

issued July 26, 2018, the amount of underpayment should be restated to be \$3,810.16 rather than

the incorrect figure of \$2,508.00 set forth in the original Order.

B. This decision corrects the error in Paragraph B, which should read: "Tempo

Telecom, LLC, is to submit KUSF True-up audit reports for the period of July 2016 through March

2018 and make additional payment of \$3,810.16 to the KUSF within 30-days of the issuance of

this Order."

C. The Commission retains jurisdiction over Tempo Telecom, LLC, and the subject

matter of this Docket for the purpose of issuing such additional orders as it may deem necessary.
