**ORDER APPROVING MODIFICATION TO INTERCONNECTION
AGREEMENT**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and having been duly advised in the premises, the Commission finds and concludes as follows:

1. On November 2, 2005, the Commission issued an order approving an Interconnection Agreement between Southwestern Bell Telephone, L.P. ("SWBT") and Comcast Phone of Kansas, LLC ("Comcast").

2. On November 7, 2008, SWBT submitted an application to the Commission for approval of a modification to the previously approved Agreement. The modification amends the Agreement to extend its expiration date to December 13, 2011.

3. Comcast is properly registered with the Kansas Secretary of State's office and is currently "active and in good standing" with that office.

4. SWBT affirmed that this agreement complies fully with the Telecommunication Act of 1996, section 252(e) because it is consistent with the public

interest, convenience, and necessity, and does not discriminate against any telecommunications carrier not a party to the Agreement.

5. There are no outstanding issues between the parties that require mediation or arbitration.

6. The Commission finds and concludes that the modification to the Agreement between SWBT and Comcast to extend its expiration date to December 13, 2011 should be approved. The implementation of the Agreement is consistent with the public interest, convenience, and necessity, and on its face does not discriminate against any telecommunications provider not a party to the Agreement.

THE COMMISSION THEREFORE ORDERS THAT:

A. The application of Southwestern Bell Telephone, L.P. for approval of a modification to its Interconnection Agreement with Comcast Phone of Kansas, LLC extending its expiration date to December 13, 2011 is approved.

B. A party may file a petition for reconsideration of this Order within fifteen (15) days from the date of service of this Order. If service is by mail, service is complete upon mailing and three (3) days shall be added to the above fifteen (15) day period. K.S.A. 66-118b; K.S.A. 2007 Supp. 77-529.

C. The Commission retains jurisdiction over the subject matter and the parties for entering such further orders, or order, as it may deem necessary.


