- 1. On October 22, 2018, Abercrombie Energy, LLC (Operator) filed an Application to authorize injection of saltwater into the Mississippi formation at the Brown #1-26 well, located in Seward County, Kansas. A hearing on the Application is currently scheduled for May 16, 2019, and the first pre-filed direct testimony deadline is March 25, 2019.<sup>2</sup>
- 2. On March 25, 2019, Operator filed an uncontested motion to continue the evidentiary hearing, as well as to continue the first pre-filed direct testimony deadline.
