**PREHEARING OFFICER ORDER SETTING PROCEDURAL SCHEDULE**

1.        The Prehearing Officer finds that a procedural schedule should be established. At a prehearing conference held on September 1, 2015, all parties agreed to the following schedule:

Staff’s Pre-filed Direct Testimony	Due by October 26, 2015
Appellant’s Pre-filed Direct Testimony	Due by November 2, 2015
Staff’s Pre-filed Rebuttal Testimony	Due by November 9, 2015
Evidentiary Hearing before the Commission 266 N. Main, Suite 220, Wichita, Kansas 67202	November 19, 2015, 10:00 a.m.

2.        Parties should note the following:
- a.    Failure to submit pre-filed testimony will likely result in the Commission restricting the right to testify and present evidence at hearing.
  - b.    At hearing, the Commission may limit direct and rebuttal testimony to the pre-filed testimony.
  - c.    Any settlement agreement the parties wish to present for the Commission’s consideration shall be due by November 9, 2015.

- d. Any person requiring special accommodations under the Americans with Disabilities Act is asked to give notice to the Commission at least 10 days prior to the scheduled hearing date.
