STAFF REPORT

Staff of the Kansas Corporation Commission (Staff and Commission, respectively) submits the following report regarding the issues which remain outstanding regarding the referenced docket. In support of its report, Staff states the following:

- 1. On August 7, 2025, a status conference was held regarding the captioned docket. During the status conference, the presiding officer requested that Staff submit a report in the docket providing an overview of which wells and/or injection authorities had not been transferred from Daylight Petroleum, LLC to Bluejacket Operating, LLC.
- 2. To date, all of the Request for Change of Operator (T-1) forms transferring wells from Daylight Petroleum, LLC to Bluejacket Operating, LLC have been processed by Staff. However, Staff has identified 12 injection wells for which it does not approve transferring the authority to operate pursuant to K.A.R. 82-3-410(a). A copy of these wells, as well as the wells at issue within the quarter-mile area of review of each injection well, is attached as Exhibit A. In addition to this filing, Staff is sending a letter to Bluejacket Operating, LLC which references the wells identified in Exhibit A for which Staff currently does not approve the transfer of injection authority.

WHEREFORE, Staff respectfully submits this report to outline the specific issues remaining in order to allow further development of this matter.
