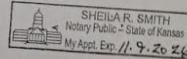

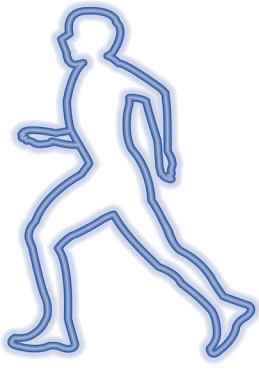
# Northwest Kansas Challenge Race in Atwood on July 4

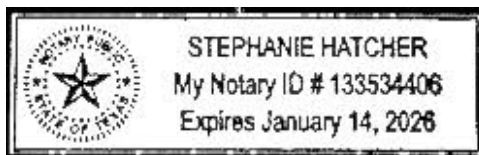
