#### **APPLICATION**

COMES NOW, F.G. Holl Company, L.L.C. "Applicant" in support of its Application in the above captioned matter and states as follows:

- 1. Applicant is a Kansas limited liability company duly authorized by the Kansas Corporation Commission and is in good standing with the Kansas Secretary of State's office to do business in Kansas with a mailing address of 9431 E. Central Avenue, Suite 100, Wichita, Kansas 67206.
- 2. The Commission has issued F.G. Holl Company, L.L.C. oil and gas operator's License No. 5056, which is in full force and in effect through June 30, 2020.
- 3. Applicant is the owner and operator of the Calcara #3-19 well located in Barton County, Kansas:
- 53' South & 63' West of the northeast quarter of the northwest quarter of the southeast quarter of Section 19, Township 19 South, Range 14 West.
- 4. K.A.R. 82-3-100 states that the Commission may grant an exception to the requirement of any of its regulations.
- 5. Applicant respectfully requests an exception to the deadline for closing the drilling pits as provided in K.A.R. 82-3-602. Applicant hopes to be able to fill the drilling pits within three months from the date of this application and is therefore seeking three months extension. Applicant has received a six months extension but due to excessive moisture from rainfall received in the earlier months of this year Applicant is not able to close the drilling pits at the moment.
  - 6. Applicant already hauled off all the drilling fluids from the reserve pits on July 3, 2018.
- 7. Applicant has been unable to close the pits within the recommended 365 days from date of spud and also during the two three-months extensions previously granted by the commission, due to persistent rainfall from the time the well was drilled coupled with very wet spring and summer this year. The second three months extension expired on November 20, 2019.

8. The names and address of land owners on whose land the subject well and pits are located are: Mark & Melanie Calcara, 702 NW 10 Road, Great Bend, Kansas 67530.

Exhibit "A" is attached and lists names and addresses of all un-leased mineral owners and operators of leases of record within one-half (1/2) mile radius of the subject well. Attached to Exhibit A is certificate of service for notification.

- 9. Applicant also submits Exhibit B which is a plat map showing location of the Calcara #3-19 well.
- 10. Notice of this Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this matter will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, F.G. Holl Company, LLC prays that this Application be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Applicant's request, for an exception to the K.A.R. 82-3-602 three hundred sixty five days from well spud date and two three-months extensions after that if needed.
