BACKGROUND:

On January 30, 2009 Southwestern Bell Telephone d/b/a AT&T Kansas ("AT&T") filed this application for approval of an Interconnection Agreement with HCI Telecom, Inc. ("HCI").

ANALYSIS:

AT&T Kansas affirms that implementation of this Agreement complies fully with Section 252(e) of the Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier. Southwestern Bell Telephony d/b/a AT&T Kansas and HCI Telecom, Inc. deems this agreement promotes diversity, and increases telecommunications services in the state of Kansas.

HCI Telecom, Inc. was granted a Certificate of Convenience and Authority on October 31, 2008 in Docket No. 09-HCIT-245-COC as a competitive local exchange carrier (CLEC) to provide private line data services.

HCI Telecom, Inc. is registered with the Kansas Secretary of State's office and is currently "active and in good standing."

Staff has reviewed this interconnection agreement between AT&T Kansas and HCI Telecom, and Staff does not have any concerns with approving
