**ORDER OPENING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (“Commission”). Having reviewed its pleadings and records, the Commission makes the following findings:

1.        On November 9, 2023, Evergy Kansas Central, Inc., Evergy Kansas South, Inc. (together, “Evergy Kansas Central”) and Evergy Kansas Metro, Inc. (collectively, “Evergy”) filed an Application to establish a new docket for the next cycle of triennial Integrated Resource Plan (“IRP”) filings, to be made from 2024—2026 as set forth in the Commission’s Order Adopting Integrated Resource Plan and Capital Plan Framework filed on February 6, 2020, in Docket 19-KCPE-096-CPL (“19-096 Docket”).
2.        Evergy further requested all parties to the 19-096 Docket be automatically granted intervention in the new docket.
3.        Commission Staff is supportive of the request. There are no objections on the record to Evergy’s request.
4.        Since Evergy’s Application is unopposed, and will promote administrative efficiency, the Commission Evergy’s Application. This Docket will handle activities and

documentation pertaining to the 2024 Triennial IRP filing and the two Annual Updates that follow in 2025 and 2026.

**THEREFORE, THE COMMISSION ORDERS:**

A. Evergy's Application is approved. Filings related to Evergy's 2024 IRP and two Annual Updates shall be made in this Docket.

B. All parties to the 19-096 Docket will be automatically granted intervention in this Docket upon filing an Entry of Appearance.

C. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>
