**ORDER GRANTING MOTION TO AMEND APPLICATION**

The above captioned matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and record, and being duly advised in the premises, the Commission makes the following findings:

1. On November 1, 2016, ONEOK NGL Pipeline, L.L.C. (ONEOK) filed an Application requesting Commission approval to cancel its Tariff K.C.C. No. 10.0 Proportional Local Pipeline Tariff (Tariff K.C.C. No. 10.0). Tariff K.C.C. No. 10.0 established new transportation movement and rates originating in four Kansas counties (Grant, Kingman, Reno, and Seward) destined for Hutchinson, Kansas on pipeline capacity leased by ONEOK. ONEOK submitted with its Application its new Tariff K.C.C. No. 10.1 cancelling in its entirety the company's Tariff K.C.C. No. 10.0, effective November 1, 2016, or the date of issuance of the Commission's Order approving the requested cancellation, whichever date is later.<sup>1</sup>

2. On November 17, 2016, the Commission issued a Suspension Order in this matter suspending ONEOK's Application for a period of 240 days from the date the Application was filed, November 1, 2016, until June 29, 2017, pursuant to K.S.A. 66-117(c).

3. On November 18, 2016, ONEOK filed a Motion to Amend Application requesting that the effective date of the company's requested cancellation of its Tariff K.C.C.

No. 10.0 be changed from November 1, 2016 to February 1, 2017. ONEOK's request to change the effective date of cancellation to February 1, 2017, is for the purpose allowing shipper(s) to continue making movements under the tariff until the operator of the Hutchinson Fractionator has repaired a leak at its facility, which should be accomplished on or before February 1, 2017. ONEOK adds that it has extended the capacity lease agreement with the owner of the pipeline in order to provide such service until the leak repair at the Hutchinson Fractionator can be completed.<sup>2</sup>

4. Upon review of ONEOK's Motion to Amend Application, the Commission finds the company's requested change in the effective date for cancellation of the company's Tariff K.C.C. No. 10.0 to be reasonable, appropriate, and in the public interest, and that the same should be granted.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

(A) ONEOK NGL Pipeline, L.L.C.'s Motion to Amend Application filed in this Matter on November 18, 2016, is hereby granted and the requested change in effective date for cancellation of the company's Tariff K.C.C. No. 10.0, from November 1, 2016 to February 1, 2017, or the date of issuance of the Commission's Order approving the requested cancellation, whichever date is later, is hereby approved.

(B) A party may file a petition for reconsideration of this Order within fifteen (15) days from the date of service of this Order. If service is by mail, service is complete upon mailing and three (3) days shall be added to the above time frame.

(C) The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary and proper.


