**ORDER ADOPTING AUDIT REPORT AND CLOSING DOCKET**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

1. On July 30, 2015, the Commission directed GVNW Consulting, Inc. (GVNW) to perform an audit of WTC Communications, Inc. (WTC) for Kansas Universal Service Fund (KUSF) purposes.

2. On January 19, 2016, GVNW filed its Audit Report of even date indicating its finding that WTC is current with its KUSF obligations and has no KUSF audit deficiencies related to the current audit period. Consequently, GVNW recommends the Commission close this docket.

3. The Commission has reviewed GVNW's January 19, 2016 Audit Report filing and concludes that it should accept and adopt the same and close this docket.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**


A. The Commission accepts and adopts GVNW Consulting, Inc.'s Audit Report filed January 19, 2016. This docket is hereby closed.

B. The Commission retains jurisdiction over WTC Communications, Inc. and the subject matter of this Docket for the purpose of issuing such additional orders as it may deem necessary.
