Thank you for taking time to speak with me on the phone a few days ago regarding the above truck inspection. As we discussed I would like to request an administrative hearing regarding this inspection and the associated \$500 fine (Invoice H000578011). I was delayed in receiving this correspondence as I live in a different city than where the initial letter was sent. After speaking with two different non-officer employees at the highway patrol I do not agree with this inspection results and fine.

I spoke with Nathan at the highway patrol prior to our conversation and he referenced some notes by the officer at the scale that were not included with the inspection report. I asked if I could have a copy of those notes and he said they did not give those out. After speaking with you I contacted the highway patrol and spoke with Nathan again and told him I was going to make this request for a hearing and I really needed a copy of the notes. He refused to provide me a copy without a subpoena. That makes it rather difficult for me to argue a point if I don't know exactly what the inspection officer said in the notes. He read me a portion of the notes and from what he said there were in my opinion some significant inaccuracies. For example he told me the notes said the driver had six hours of personal conveyance during his driving day. Attached is a copy of his elog printouts for the day of the inspection and the previous seven days and there is no six hours of personal conveyance during day.

Also we have had a number of problems with our elog devices to the point we recently replaced them with a different manufacturer. I believe this may have also had a role in the cause of the alleged violations. Attached is correspondence related to problems with the log devices.

Please let me know if I can be scheduled for a telephone hearing to discuss this further. Thank you for your consideration of this request.

National Fleet Tracking (NFT) introduced their ELOG product to take advantage of the ELD mandate. They were a GPS provider prior to that and we had used their product with no problems and that is why we chose them for our ELOG devices. In my opinion they did not realize how complex the ELOG process would be and simply got in over their head. Their ELOG product has never consistently worked properly since December of 2016 when we initially installed them. We have had roughly 30 or more conversations over the past year with their technical support and management about our problems. Devices would not connect with the tablet, the tablet would lock up and there were numerous software issues with not recording hours correctly. We have had all the devices replaced twice with new devices. We have been told on four different occasions here is a new software update which should fix the problems and every time it did not totally fix the problems and we continued to have problems. We finally reached the point where we have been put out of service several times recently specifically because the ELOG device was not functioning properly and we were cited for HOS violations. This was totally unacceptable so as the business owner I made the decision to change to the Omnitracs ELOG device. Attached is a copy of the invoice and paid receipt to document these really have been ordered and paid for. I am requesting the 30 day extension based on an approximate week to ten days for Omnitracs to fulfill, ship and us to receive the new devices and 2 to 3 weeks to get our drivers back to our shop location to change the ELOG device and train the drivers on the new device. This is because our drivers are usually out for 2 to 3 weeks at a time before returning to our shop. I cannot afford more out of service violations due to the existing devices not working properly and we continue to have current problems with the existing devices. I had a driver put out of service last weekend because he had been on paper logs for 8 days and after repeated efforts we still could not get the ELOG device to work. Therefore I request a 30 day extension or exemption in order to complete the transition process from our current ELD devices to the new Omnitracs devices. Thank you for your consideration of this request. Please let me know as soon as you can as we continue to have problems with our current devices. Thanks.

We installed and began using the National Fleet Tracking elog product last December and have had numerous problems with them to the point we had to make a change. We have actually been put out of service several times because the elog device failed to work properly. I have placed an order with Omnitracs for replacement elog devices and estimate with the delivery time, getting our trucks back to our location for installation and driver training the entire conversion process will take approximately 30 days.

The reason for this request is our existing elog devices continue to malfunction. I had a driver put out of service in Oregon yesterday 12-18-18 because his elog device was not working properly. I know we can go on paper logs for up to 8 days but I don't believe there is any way we can have this conversion done in that length of time and I can't afford to take trucks out of service until the new devices are installed that would basically put me out of business. We can't continue to be put out of service because of a faulty elog device.
