# ORDER GRANTING CEBRIDGE TELECOM'S MOTION TO WITHDRAW ITS APPLICATION FOR APPROVAL OF AN INTERCONNECTION AGREEMENT

Docket No. 13-CKST-711-COC

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings and conclusions.

- 1. On August 29, 2013, in Docket No. 13-CKST-711-COC, the Commission granted Cebridge Telecom KS, d/b/a Suddenlink Communications (Cebridge) a Certificate of Convenience and Authority to provide Competitive Local Exchange and Exchange Access Telecommunications Services within the State of Kansas.<sup>1</sup>
- 2. On September 12, 2023, in Docket No. 24-CKST-248-IAT, Cebridge filed an Application for Approval of an Interconnection Agreement with MoKan Dial, Inc. (MoKan).

- 3. On September 15, 2023, certain rural telephone companies<sup>2</sup> (RLECs) filed a Petition to Intervene, Objection to Interconnection Agreement and Petition to Appropriately Limit CLEC Certificate of Convenience, claiming Suddenlink lacks authority to operate in MoKan's service area, and thus cannot legally enter into an interconnection agreement.<sup>3</sup> The RLECs also argue that Suddenlink's certificate must be amended in the 13-CKST-711-COC Docket to appropriately limit Suddenlink's operating authority to AT&T and CenturyLink legacy territory.<sup>4</sup> The RLECs were granted intervention on November 21, 2023.<sup>5</sup>
- 4. On December 4, 2023, Cebridge filed a Motion to Withdraw its Application for Approval of an Interconnection Agreement, explaining an interconnection agreement is no longer needed, and both Cebridge and MoKan wish to withdraw the Application.<sup>6</sup>
- 5. By statute, the Commission has ninety days from the date the Application was filed to issue a decision, otherwise, the Application is approved as a matter of law. Since it appears that the Motion is unopposed, the Commission agrees that granting the Motion to Withdraw will not unduly burden or prejudice any party. Accordingly, the Commission grants Cebridge's Motion to Withdraw its Application for Approval of an Interconnection Agreement.
