ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE RESPONSE

The above matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission finds and concludes as follows:

1. Coffeyville Resources Refining & Marketing, LLC (CRRM) filed a complaint against Mid-America Pipeline Company, LLC (MAPL) on January 3, 2012. The Commission initiated this docket and mailed the complaint to MAPL on January 4, 2012. Computing the time for filing a response to CRRM's complaint, MAPL calculates its Response is due January 17, 2012. The Commission has jurisdiction over this complaint under K.S.A. 2010 Supp. 66-104 and K.A.R. 82-1-220.

2. On January 13, 2012, MAPL filed a Motion asking for an extension of time to file its Response to CRRM's Complaint. In its Motion, MAPL noted that settlement discussions were held between MAPL and CRRM on January 11, 2012, in Docket No. 12-MDAP-068-RTS (12-068). As a result of those discussions, parties to that docket have requested a stay in Docket 12-068 to allow for further settlement negotiations. This request was granted in the Order Granting Joint Motion to Modify Procedural Schedule filed in Docket 12-068 on January 19, 2011. Because those ongoing settlement negotiations may resolve all disputes between MAPL and CRRM, MAPL requests that it be allowed to file its response in this docket on March 26, 2012. MAPL consulted with CRRM and the Commission's staff and neither object to this request for an extension.

FINDINGS AND CONCLUSIONS

3. The Commission encourages the parties to work through settlement negotiations to resolve the dispute that resulted in the filing of Docket 12-068 as well as this proceeding. The Commission grants MAPL's request for an extension of time to file a Response to CRRM's Complaint. MAPL's Response is due on March 26, 2012.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

(A) The Commission grants MAPL's Motion for Extension of Time to file a Response to CRRM's Complaint and extends MAPL's deadline to respond to March 26, 2012.

(B) This Order will be served using United States mail or hand-delivery. Parties have 15 days, plus three days if service of this Order is by mail, from the date of service of this Order in which to petition the Commission for reconsideration. K.S.A. 66-118b; K.S.A. 2010 Supp. 77-529(a)(1).

(C) The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further order or orders as it may deem necessary.
