### JOINT MOTION FOR PROCEDURAL ORDER

Southern Pioneer Electric Company (Southern Pioneer), the Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), and the Citizens' Utility Ratepayers Board (CURB), (collectively referred to as Joint Movants) hereby move the Commission for an Order establishing a procedural schedule in the above-captioned matter. In support of its motion, Joint Movants state the following:

1. On October 10, 2019, Southern Pioneer filed its Application seeking approval to make certain changes to its rates for electric service.<sup>1</sup> The filing was made in accordance with the provisions of K.S.A. 66-117 and the Commission's *Order Acknowledging Notice of Intent to Continue Formula-Based Ratemaking Plan* issued on January 15, 2019, in Docket No. 19-SPEE-240-MIS (19-240 Order).

2. On October 17, 2019, the Commission issued an Order suspending this docket for 240 days, until June 8, 2020.

3. Joint Movants conferred in order to develop a procedural schedule for this docket to propose to the Commission for consideration. That proposed schedule, as agreed to by Joint Movants, is as follows:
