**STATUS UPDATE RECOMMENDING 30-DAY EXTENSION**

On June 11, 2020, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.<sup>1</sup> The Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.<sup>2</sup>

On June 20, 2025, Operator requested a 30-day extension of its June 30, 2025, deadline. The District #3 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Under the Agreement, Commission Staff recommends that Operator's June 30, 2025, deadline be extended to July 30, 2025. All other deadlines would remain the same.
