ORDER APPROVING EXTENSION OF TIME

The Commission rules as follows:

1. On October 8, 2019, the Commission issued an Order Approving Compliance Agreement. The Compliance Agreement stated that Operator had nine wells out of compliance with K.A.R. 82-3-111.¹ Under the Compliance Agreement, Operator was to plug one well by November 1, 2019, and one additional well each three calendar months thereafter, resulting in annual quarterly deadlines of February 1, May 1, August 1, and November 1, with all wells being returned to compliance by November 1, 2021.²

2. On October 27, 2020, Commission Staff filed a status update in this docket, stating that Operator had timely requested a 30-day extension of its November 1, 2020, quarterly deadline, as permitted under the terms of the Compliance Agreement. Staff recommended approval of the requested extension, reporting that Operator was currently in compliance with the Compliance Agreement and had demonstrated to Staff financial and environmental-related good cause for the request.

² Id. at Compliance Agreement ¶ 2. The Agreement states the deadlines would result in all wells being returned to compliance by October 31, 2021. Under the described terms, however, Operator would actually have until November 1, 2021.

3. Taking administrative notice of its records and upon reviewing Staff's status update, the Commission finds it appropriate to grant Operator's request.

THEREFORE, THE COMMISSION ORDERS:

A. Operator's request is granted. Operator shall have until December 1, 2020, to

meet the November 1, 2020, deadline described in the Compliance Agreement.

All other deadlines in this matter remain unchanged. B.
