This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On April 10, 2018, the Commission issued a Penalty Order against Rick Housel dba

Rick's Well Service (Operator) for failure to comply with K.A.R. 82-3-107 and K.A.R. 82-3-130 due to the Operator's failure to submit a complete and accurate well completion report, with the associated documents, within 120 days of the spud date.<sup>1</sup>

2. On May 2, 2018, the Operator filed a letter requesting a hearing.

3. On May 24, 2018, the Commission issued an Order Designating Prehearing Officer

and Setting Prehearing Conference, scheduling a Prehearing Conference for July 12, 2018.<sup>2</sup>

4. An evidentiary hearing was scheduled for October 18, 2018.<sup>3</sup>

On September 14, 2018, the Operator submitted a letter withdrawing his request for 5. hearing, noting that he had paid the fine on the *Penalty Order*.<sup>4</sup>

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>5</sup>

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
