In support of its Motion, Staff states as follows:

1. On August 15, 2017, the Commission received a written request from Leon Shestak requesting a hearing in this matter
2. On February 8, 2018, the Commission issued its Order Setting Hearing in this matter, scheduling a hearing for April 26, 2018 at 10:30 a.m.
3. On April 13, 2018, counsel for Staff and Leon Shestak spoke by telephone and believe a settlement has been reached pending submission of a Joint Motion for Approval of Stipulated Settlement Agreement.
4. Staff therefore requests that the hearing in this matter be continued pending the filing of settlement documents and that the filing date for the parties' prefiled direct testimony be extended to ten days prior to a new hearing date, should one be set.



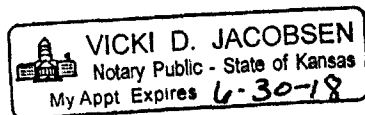


