

**MOTION TO CANCEL HEARING AND CLOSE DOCKET**

On October 18, 2016, the Commission issued a Penalty Order against Operator, assessing a \$3,000 penalty and directing Operator to either conduct mechanical integrity tests on three wells or to plug them. Operator timely appealed. Various pleadings have resulted in the matter being set for an April 20, 2017, evidentiary hearing.

Since the Penalty Order was issued, the three wells have been tested or plugged. Today, Operator's counsel submitted the \$3,000 payment. Operator's counsel has verbally indicated to Staff's counsel that Operator no longer wishes to appeal the Penalty Order. Operator's counsel has also submitted the attached document, requesting that the docket be closed. Accordingly, Staff motions the Commission to consider Operator's appeal to be withdrawn, for the currently scheduled hearing to be cancelled, and for the docket to be closed.




