- 2. That application was approved on June 6, 2017, in Docket No. 17-SFLT-283-ACQ.
- 3. Consolidated Communications is now preparing to make changes to its organization structure, effective January 1, 2019. A copy of the existing organization charts and the organization chart as it will look after January 1, 2019, is attached as Exhibit A.

Corporate Legal Entity Chart - Post Consolidation Consolidated Communications Holdings, Inc. & Subsidiaries


