ORDER APPROVING ADDITION OF WELLS AND EXTENSION OF FINAL DEADLINE

On October 8, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement). The Agreement stated Operator had nine wells out of compliance with K.A.R. 82-3-111. Under the Agreement, Operator was to bring one well into compliance by November 1, 2019, and one additional well each three calendar months thereafter, for a final deadline of November 1, 2021. The Agreement also provided that it may be amended to add additional wells with written consent of the District Supervisor, and that upon Commission Staff filing a status update, the addition of wells would be considered by the Commission for possible approval.²

On August 8, 2021, Staff filed a *Status Update to Compliance Agreement*, wherein it recommended an additional well be added to the Agreement, thereby bringing the total well count to ten, and the final deadline to February 1, 2022. On August 26, 2021, the Commission issued an *Order Approving Addition of Wells and Extension of Final Deadline* adopting Staff's recommendation. To date, Operator has brought the ten wells into compliance with Commission regulations, and as such is in compliance with the Agreement.

On January 19, 2022, Staff filed a status update to add five new wells to the Agreement.

The Commission approves the additions. Under the Agreement, the number of wells to be brought into compliance each calendar month remains the same; the final deadline is now

May 1, 2023.
