**ORDER SETTING PROCEDURAL SCHEDULE**

This matter comes before the State Corporation Commission of the State of Kansas (“Commission”) for consideration and decision. Having examined its files and records, the Commission finds and concludes:

**I. Background**

1. On September 11, 2025, Southern Pioneer Electric Company (“Southern Pioneer”) filed an application in the above-captioned docket seeking Commission approval of changes to its Parallel Generation Rider and Net Metering Rider.<sup>1</sup>
2. On September 23, 2025, the Commission issued an order in the above-captioned docket granting the petition of the Citizens’ Utility Ratepayer Board (“CURB”) to intervene and for a protective and discovery order.
3. On September 25, 2025, the Commission issued an order in the above-captioned docket suspending the deadline for Commission action in the docket to May 11, 2026, pursuant to K.S.A. 66-117(c).<sup>2</sup>
