# PREHEARING OFFICER ORDER CANCELLING PREHEARING CONFERENCE

The Prehearing Officer makes the following findings:

- 1. On April 23, 2019, the Commission issued a *Penalty Order* against Tauy Oil, Inc. (Operator) for fourteen violations of K.A.R. 82-3-409 for failure to file annual fluid injection reports.<sup>1</sup> On May 6, 2019, Operator filed a request for hearing.<sup>2</sup>
- 2. On June 19, 2019, Commission Staff sent emails to the Prehearing Officer, cc'ing Operator, in which Staff stated that it anticipated filing a settlement agreement next week and that a prehearing conference was therefore unnecessary. Staff included an email chain wherein parties agree to basic settlement terms, and wherein Operator indicated its assumption that the prehearing conference would be cancelled.
  - 3. The Prehearing Officer agrees that a prehearing conference is unnecessary at this time.

#### THEREFORE, THE PREHEARING OFFICER ORDERS:

A. The prehearing conference scheduled for June 21, 2019,<sup>3</sup> is cancelled.
