PREHEARING OFFICER ORDER
CANCELLING PREHEARING CONFERENCE

The Prehearing Officer makes the following findings:

1. On April 23, 2019, the Commission issued a *Penalty Order* against Taury Oil, Inc. (Operator) for fourteen violations of K.A.R. 82-3-409 for failure to file annual fluid injection reports.¹ On May 6, 2019, Operator filed a request for hearing.²

2. On June 19, 2019, Commission Staff sent emails to the Prehearing Officer, cc'ing Operator, in which Staff stated that it anticipated filing a settlement agreement next week and that a prehearing conference was therefore unnecessary. Staff included an email chain wherein parties agree to basic settlement terms, and wherein Operator indicated its assumption that the prehearing conference would be cancelled.

3. The Prehearing Officer agrees that a prehearing conference is unnecessary at this time.

THEREFORE, THE PREHEARING OFFICER ORDERS:

A. The prehearing conference scheduled for June 21, 2019,³ is cancelled.
