ORDER APPROVING ADDITION OF WELLS AND EXTENSION OF FINAL DEADLINE

On March 21, 2019, the Commission issued an Order Approving Compliance Agreement, requiring Operator to bring 29 identified wells into compliance with K.A.R. 82-3-111 at a rate of two wells by June 30, 2019, and an additional three wells each three calendar months thereafter, for a final deadline of September 30, 2021. The Agreement provided that it may be amended to add additional wells with the written consent of the District Supervisor, and that upon Commission Staff filing a status update amending the Agreement, the addition of wells would be considered by the Commission for possible approval.

On October 27, 2020, Staff filed a status update to add one well and on October 6, 2021, Staff filed a status update to add one well, and recommended extending the final compliance deadline to December 31, 2021. Upon review, the Commission approves the additions. Pursuant to the Agreement, the number of wells to be brought into compliance each calendar month remains the same; the final deadline is extended to December 31, 2021.
