### **ORDER DESIGNATING PRESIDING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On July 28, 2025, Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (Evergy Kansas Central) and Evergy Kansas Metro, Inc. d/b/a Evergy Kansas Metro (Evergy Kansas Metro) (together as Evergy) requested expedited processing of proposed tariff revisions related to third-party credit card processing fees and transaction limitations. Evergy seeks to remove the \$5,000 per transaction limit for non-residential customers, and to remove ATM cards as an allowable payment type for all customers.
- 2. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA).
