You are hereby notified that Grand
Mesa Operating Company ("Opera-
tor"), has filed with the Kansas Cor-
poration Commission an application
requesting a well location exception
and full oil and gas allowable for its
Moeckel Unit 1-32 well to be located
730' from the West line and 183' from
the North line of Section 32-T23S-
R9W, Reno County, Kansas, which
location is 123' from the eastern
boundary of the Moeckel Unit. Oper-
ator plans to drill the well to a depth
of 5,000' measured from surface to
test the Viola formation for oil and gas
reserves.

The application is pending with the
Commission. Any persons who object
or protest to such application shall
be required to file their objections or
protests in writing with the Commis-
sion within 15 days from the date of
this publication. If a written protest
is not timely filed, the application
may be determined administratively
by the Commission and may thereby

rights, cause waste or pollution. Ob-

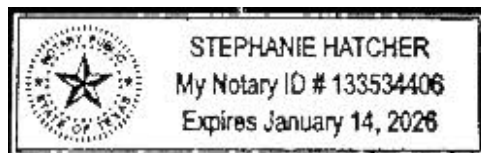
