### APPLICATION

COMES NOW, F.G. Holl Company, L.L.C. "Applicant" in support of its application in the captioned matter and states as follows:

1. F.G. Holl Company is a Kansas limited liability company duly authorized by the Kansas

Corporation Commission and is in good standing with the Kansas Secretary of State's office to do

business in Kansas with a mailing address of 9431 E. Central Avenue, Suite 100, Wichita, Kansas 67206.

2. The Commission has issued F.G. Holl Company oil and gas operator's License No. 5056,

which is in full force and in effect through June 30, 2025.

3. F.G. Holl Company is the operator of the Box Ranch "A" well, API #15-033-

21,586-0000, located in Comanche County, Kansas: Northwest (NW/4) of Section 12, Township 35

South, Range 20 West.

4. Pursuant to K.A.R. 82-3-111, the well will have been shut in for 10 years as of November

15, 2014, and the Applicant obtained temporary abandonment status for subject well since November 3, 2015.

5. K.A.R. 82-3-111 imposes a 10-year limitation on the length of time during which wells

may be temporarily abandoned, but an exception to the 10-year limitation may be obtained pursuant to said regulation through an application filed with the Commission pursuant to K.A.R. 82-3-100. Applicant

seeks such an exception.

6. Applicant wishes to continue with the TA status for the subject well because Applicant intends to use the well for gas production. Applicant has plans to rework the well in the Mississippi Formation for Oil & Gas and put it back to production. The well sold 22,386 MCF from Viola Formation 2012 to 2014. There is already a gas pipeline laid out.

7. F.G. Holl Company, LLC is working on getting a Casing Integrity Test (CIT) done and will be submitting its report as soon as it is received.

8. Applicant has included a plat map showing the locations of all producing wells, injection, temporary abandoned, abandoned, and plugged wells located on the same leased premises as the subject well.

10. Listed in the attached Exhibit "A" are the names and addresses of the following persons:

A. Operator of each oil and gas lease covering lands within one-half (1/2) mile

radius of the subject well; and

B. Each person who owns any mineral interest of record in and under and lands located within one-half (1/2) mile radius of subject well (provided that such mineral interest is not covered by any oil and gas lease).

9. Among the attachments is a Certificate of Service listing names and addresses of the recipients of the Notice of application, in the form of a copy of the Application, which has been mailed on November 12, 2024.

10. Applicant has attached information about the status of the well and pending plans for putting the well back to production.

11. Notice of this Application will be published pursuant to K.A.R. 82-3-135a after the Commission has received and accepted the Application. In addition, notice of the hearing to be held on this matter will be provided as prescribed by K.A.R. 82-3-135.

12. Based on the foregoing, Applicant requests the Commission to grant an exception to the 10-year limitation, specifically to allow the subject well to remain eligible for temporary abandonment status for another three (3) years following the expiration of the current 10-year limitation. Applicant understands that the exception would be valid for three (3) years, but Applicant would still need to apply annually to the Conservation Division District Office for approval of an application for temporary abandonment status.


WHEREFORE, F.G. Holl Company prays that this Application be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Applicant's request, for an exception to the K.A.R. 82-3-111 ten (10) year limitation, to allow the subject well to remain temporarily abandoned for three (3) years, subject to annual approval by the Conservation Division Office of an application for temporary abandonment status.

Lease Details:

- 1. Box Ranch "A" -12 lease is NW/4 of Sec. 12-35S-20W, Comanche County. The lease has only one well, the Box Ranch "A" #1-12, located SE SW NW/4 Sec. 12-35S-20W.
- 2. It would cost about \$26,000 to plug this well.
- 3. The well was drilled in June of 2011, completed on October 20, 2011, and produced from Viola Formation until it was shut in in November of 2014. The well sold 22,386 MCF Gas 2012-2014.
- 4. The plan is to set CIBP above the Viola Formation, squeeze the perforations in the Mississippi, and recomplete in the Mississippi for Oil &Gas. The estimated completion cost is \$55,000.


