ORDER GRANTING EXTENSION OF TIME TO FILE AN ANSWER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined and considered Atmos Energy's Motion for Extension of Time, the Commission finds as follows:

- 1. On July 22, 2015, DH Pace Company filed with the Commission a Complaint against Atmos Energy. The Complaint was mailed to Atmos Energy on August 5, 2015.
- 2. On August 14, 2015, Atmos Energy filed a Motion for Extension of Time, requesting until August 25, 2015, to review DH Pace's Complaint and file an answer to said Complaint. Prior to filing its Motion, Atmos Energy confirmed with Commission Staff (Staff) that Staff had no objection to the requested extension of time.
- 3. On August 25, 2015, Atmos Energy filed its Answer to DH Pace's Complaint.

 Although subsequent to the filing of the aforementioned Answer, Staff recommended approval of Atmos Energy's requested extension of time.
- 4. The Commission finds Staff's recommendation to be reasonable and hereby adopts the same.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. Atmos Energy's Motion for Extension of Time is hereby granted.

- B. The parties have fifteen (15) days, plus three (3) days if mailed service, from the date this Order was served in which to petition for reconsideration. K.S.A. 66-118b; K.S.A. 77-529(a)(1).
- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders, as necessary.
