Staff timely submitted its pre-filed direct testimony. On November 22, 2024, Operator motioned to extend its deadline until December 13, 2024, for two witnesses, and until December 31, 2024, for a third, outside expert witness. As grounds, Operator stated additional work was needed to complete the testimony of two witnesses, its third witness had withdrawn from his engagement two days prior for reasons unrelated to the merits of the docket, and Operator's counsel had other commitments across the Thanksgiving week. On December 2, 2024, Staff filed a response, stating it was not opposed to a December 13, 2024, deadline for all witnesses, if Operator could provide a "legitimate reason" why the first two witnesses' testimonies were not timely filed. Staff also voiced concerns about fresh and usable water and recent well transfers.

On December 6, 2024, this matter was discussed at an informal status conference. Operator's deadline for the two witnesses is now December 13, 2024. It's deadline for the replacement, third witness is now December 20, 2024. Staff's new rebuttal testimony deadline will be established after Operator's testimony is submitted.
