### **ORDER RESCINDING PENALTY**

The above captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On July 17, 2018, the Commission issued a Penalty Order in this docket finding the Operator was in violation of K.A.R. 82-3-602. The Penalty Order required the Operator to pay \$100 and to submit a CDP-4 form for the pit associated with the subject well.
- 2. On July 25, 2018, Commission Staff discovered that an error was made in the internal database. The pit associated with the subject well was transferred to another operator and the required CDP-4 form was filed with the Conservation Division by that operator.
- 3. This error makes enforcement of the Penalty Order unfair and otherwise outside the interests of the State. Accordingly, Staff recommended rescission of the penalty.
- Based upon the above, the Commission concludes that Staff's recommendation is reasonable and hereby rescinds the July 17, 2018, Penalty Order in this docket.

### THEREFORE, THE COMMISSION ORDERS:

A. The Penalty Order that was issued in this docket is rescinded.

- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).<sup>1</sup>
- C. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further orders as it may deem necessary.
