APPLICATION

COMES NOW Atmos Energy and pursuant to K.S.A. 66-117, moves the Kansas Corporation Commission ("Commission") to amend its general service firm transportation service tariff (Rate Schedule FT 900) to permit customers who qualify to take service under Rate Schedule 965 (Irrigation Engine Sales Service) to obtain firm transportation service under Rate Schedule FT 900. In support hereof, Atmos Energy states:

1. Atmos Energy is a natural gas public utility operating in the state of Kansas pursuant to certificates of convenience and necessity issued by the Commission. The Company's principal place of business in Kansas is located at 25090 W. 110th Terr., Olathe, Kansas 66061.

3. Atmos Energy proposes to amend its Kansas tariffs to permit irrigation customers to


obtain firm transportation service from the utility. Atmos Energy has received requests from irrigators for firm transportation service.

4. The amendment to Atmos Energy's Rate Schedule FT 900 tariff will allow irrigation customers who use natural gas to fuel irrigation engines to obtain firm transportation services from Atmos Energy. This change in the transportation tariff will permit irrigators, who have lost their wellhead and gas gathering system gas supplies the ability to obtain another gas supply they can transport to their equipment through Atmos Energy's distribution system.

5. Attached to this Application as Exhibit A and incorporated herein by reference is a copy of the current Rate Schedule 900 tariff sheet, with the additional language adding irrigation customers to the transportation tariff highlighted in yellow.

6. The current irrigation season will start soon. Atmos Energy has had requests from irrigators to implement these changes in time for irrigation season. Atmos Energy requests that the tariff changes be approved as soon as possible.

WHEREFORE, Atmos Energy prays the Commission approve its request to amend its transportation tariff as set forth herein.


