This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On February 3, 2020, RJ Energy, LLC (Operator) filed an Application seeking authorization for injection of saltwater into twelve wells on the Murray Twin lease.¹ The same day, Operator filed an Affidavit of Publication, which stated that on January 23, 2020, The Coffey County *Republican* newspaper had published a Notice of Filing Application, which referenced the filing of an application for the twelve wells on the Murray Twin lease and ten wells on the Brewer lease.²

2. On February 12, 2020, Operator filed an Application seeking authorization for injection of saltwater into ten wells on the Brewer lease.³

On February 20, 2020, Susan Royd-Sykes and Cindy Hoedel filed letters of protest.⁴ 3.

The Commission finds a Prehearing Officer should be designated in this proceeding 4. to address any matters listed in K.S.A. 77-517(b),⁵ and a Prehearing Conference should be scheduled.

Although a Prehearing Officer is designated, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m. on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m. on the date scheduled for service, shall be accompanied by a Motion to File Out-of-Time.

C. At the Prehearing Conference, parties shall be prepared to discuss deadlines for filing testimony and briefs, discovery procedures, scheduling of a hearing with the Commission, and any other issues that will promote the orderly and prompt resolution of this proceeding.

D. At the Prehearing Conference, without further notice, this proceeding may be converted into a conference hearing or a summary proceeding for disposition of this matter as provided by the Kansas Administrative Procedure Act (KAPA). Any party that fails to attend or participate in the Prehearing Conference, hearing, or other stage of this proceeding may be held in default under the KAPA.⁶
