# ORDER GRANTING STAFF'S MOTION FOR ONE-DAY EXTENSION TO FILE CAPITAL PLAN RESPONSIVE COMMENTS AND CURB'S MOTION TO FILE **RESPONSIVE COMMENTS OUT OF TIME**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the files and records, the Commission finds the following:

- 1. On February 6, 2020, the Commission issued its Order Adopting Integrated Resource Plan and Capital Plan Framework (Order) requiring Evergy, Inc. and its operating subsidiaries to make triennial integrated resource plan filings and annual updates, and a process for the Parties to file reports not later than 150 days after Evergy's compliance filings. The Order requires Evergy to file a Capital Investment Plan by February 28<sup>th</sup> of each year, and give the parties 120 days to submit responsive comments.<sup>2</sup>
- 2. On February 28, 2024, Evergy filed its Capital Investment Plan, making comments due June 27, 2024.
- 3. On June 27, 2024, Staff filed a motion requesting a one-day extension to submit responsive comments.<sup>3</sup>

4. On June 28, 2024, the Citizens' Utility Ratepayer Board (CURB) filed a motion to

file its comments out-of-time.<sup>4</sup>

5. K.A.R. 82-1-217(b) allows the Commission to extend any deadline for good cause.

Because of the importance of the Capital Investment Plan, the Commission believes allowing the

Parties sufficient time to thoroughly analyze the Capital Investment Plan before they file their

comments would ensure the comments are informative. Therefore, pursuant to K.A.R. 82-1-

217(b), the Commission grants both Staff's Motion for One-Day Extension to File Capital

Investment Plan Responsive Comments and CURB's Motion to File its Responsive Comments

Out of Time.

THEREFORE, THE COMMISSION ORDERS:

A. Staff's Motion for One-Day Extension to File Capital Investment Plan Responsive

Comments is granted.

B. CURB's Motion to File its Responsive Comments Out-of-Time is granted.
