MOTION TO WITHDRAW REQUEST FOR HEARING

- 1. On June 29, 2017, the Kansas Corporation Commission ("Commission") issued a penalty order against Global Energy for failing to timely renew its operator's license by May 31, 2017.
 - 2. On July 7, 2017, Global Energy requested that the matter be set for hearing.
- 3. On October 10, 2017, the Commission issued its procedural order setting this matter for hearing on December 14, 2017.
- 4. Pursuant to the Commission's procedural order, Staff and Global Energy have filed testimony in this matter.
- 5. On November 29, 2017, Staff and Global Energy discussed this matter. As a result of those discussions, Global Energy has decided to file this motion to withdraw its request for a hearing, pay the \$500 penalty and seek renewal of its operator's license upon payment of the \$500 penalty. Staff has indicated it has no objection to Global Energy's motion to withdraw its request for hearing provided that Global Energy pays the \$500 penalty and seeks to renew its operator's license upon payment of the penalty.

WHEREFORE, Global Energy requests permission from the Commission to withdraw its request for hearing in this matter. Global Energy agrees to pay the \$500 penalty and seek renewal of

its operator's license.


