APPLICATION

COMES NOW, Applicant, Merit Energy Company, LLC, 13727, Noel Road, Suite 1200, Dallas, Texas 75240. Applicant herein and respectfully states as follows:

- 1. The Applicant is the owner of oil and gas leasehold interests in the subject acreage in Finney County, Kansas.
- 2. The Applicant seeks to complete the River Bend 1 well with a deviation from the surface to the top of the producing formation in excess of seven degrees (7°). The River Bend 1 well surface location is at a location 609 feet from the South line and 144 feet from the West line of Section 26, Township 24 South, Range 32 West, Finney County, Kansas. To keep the surface hole location out of the flood plan and a crop circle, a deviation of ten point eight degrees (10.8°) is necessary. The bottom hole location for the River Bend 1 well will be at 1379 feet from the South line and 631 feet from the West line of said Section 26, a legal location. The River Bend 1 well is expected to be productive from the St. Louis Formation.
- 3. Production from the River Bend 1 well will be from the St. Louis Formation. Applicant has a market for the oil and/or gas produced therefrom and production of said oil and/or gas will be for the purposes as permitted by laws of the State of Kansas so as not to constitute waste.
- 4. That attached and made a part hereof is Exhibit No. 1, a plat showing the surface location for the River Bend 1 and the intended bottom hole location.
- 5. Attached as Exhibit No. 2 is a list of each operator or lessee of record (other than the Applicant) and each owner of record of the minerals in any unleased acreage within one-half mile radius of both the surface and bottom hole locations as well as the landowner of the surface location.

6. That notice of this Application and opportunity for hearing thereon is being provided pursuant to K.A.R. 82-3-135a by mailing notice to those listed on Exhibit No. 2 and by causing the Notice of Pending Application to be published as required by the Commission in *The Wichita Eagle* and *The Garden City Telegram* newspapers. Said notice provides that unless written protest is received by the Commission within fifteen (15) days after the date of publication of said notice, the Applicant in this matter will be granted administrative approval after said 15 day period.

WHEREFORE, Applicant prays that this cause be docketed and in the event no protest is made to the Commission within the time period provided, an Order be entered permitting the completion of the River Bend 1 well with a deviation from the surface to the top of the producing formation in excess of seven degrees (7°).


