**MOTION FOR EXTENSION OF TIME TO COMPLY WITH COMMISSION
ORDER**

Sprint Communications Company LP (“Sprint”), by the undersigned, and pursuant to K.A.R. 82-1-217(b), seeks an extension of time to comply with the provision of the Commission’s Order of June 24, 2021, arising out of the audit of Sprint conducted by GVNW for KUSF Year 23, requiring Sprint to provide ten customer bills to GVNW. In support of this Motion, Sprint states the following:

1. In the Commission’s Order of June 24, 2021, the Commission required Sprint to provide copies of ten customer bills to GVNW as a means of demonstrating that Sprint had implemented a billing system change to clearly itemize and identify KUSF surcharges on customer bills.

2. Mr. Larry Weians, who prepared and signed the affidavit of compliance that Sprint filed on September 17 in this docket, was under the impression that Sprint had provided the customer bills to GVNW. That has apparently not yet occurred, but will occur soon. Sprint is asking for an additional fifteen days from the date of this filing to provide the customer bills.

Wherefore, for good cause shown, Sprint moves the Commission for an extension of fifteen days from the date of this filing to provide the ten customer bills to GVNW required by the Commission's Order of June 24.
