**STATUS UPDATE GRANTING 30-DAY EXTENSION**

On July 26, 2022, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.<sup>1</sup> The Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.<sup>2</sup> Staff will grant or deny such request.<sup>3</sup>

On November 28, 2023, Operator requested a 30-day extension of its November 30, 2023, deadline. The District #2 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Commission Staff grants Operator's extension request. Under the Agreement, Operator's November 30, 2023, deadline is extended to December 31, 2023. All other deadlines remain the same.
