APPLICATION TO CEASE

COMES NOW Westar Energy, Inc. (Westar Energy), and in support of its Application
To Cease states:

1. Westar Energy is a Kansas corporation authorized by the Commission to conduct the
business of a public utility under the provisions of K.S.A. 66-104, and as such holds a Certificate
of Convenience and Authority from this Commission to engage in the business of an electric
public utility in the State of Kansas, thereby promoting the public convenience in the following
described territory:

ATCHISON COUNTY, KANSAS

A tract of land described as the Northwest ¼ of the Northwest ¼ of Section 31,
Township 6 South, Range 21 East, in Atchison County, Kansas, as detailed on the
map marked Exhibit A and attached hereto.

JACKSON COUNTY, KANSAS

A tract of land described as the Southeast ¼ of the Northwest ¼ of Section 27,
Township 8 South, Range 15 East, in Jackson County, Kansas, as detailed on the
map marked Exhibit B and attached hereto.

JACKSON COUNTY, KANSAS

A tract of land described as the Northwest ¼ of the Southwest ¼ of Section 28,
Township 8 South, Range 15 East, in Jackson County, Kansas, as detailed on the
map marked Exhibit C and attached hereto.

LEAVENWORTH COUNTY, KANSAS

A tract of land described as the West ½ of the Southwest ¼ of the Northeast ¼

and the West ½ of the Northwest ¼ of the Southeast ¼ of Section 12, Township 11 South, Range 20 East, in Leavenworth County, Kansas, as detailed on the map marked Exhibit D and attached hereto.

JEFFERSON COUNTY, KANSAS

A tract of land described as the West ½ of the Northeast ¼ of the Southwest ¼ of Section 24, Township 8 South, Range 18 East, in Jefferson County, Kansas, as detailed on the map marked Exhibit E and attached hereto.

JEFFERSON COUNTY, KANSAS

A tract of land described as the South ½ of the North ½ of the Northeast ¼ of Section 34, Township 9 South, Range 18 East, in Jefferson County, Kansas, as detailed on the map marked Exhibit F and attached hereto.

2. Westar Energy and Leavenworth Jefferson Electric Cooperative (Leavenworth Jefferson EC) are working together to correct territory issues. Leavenworth Jefferson EC is currently serving the tracts of land described in Paragraph 1 although they are in Westar Energy's certified territory.

3. Westar Energy has agreed to cease serving the tracts of land described in Paragraph 1, subject to the Commission's approval, to correct the existing territory discrepancies.

4. Westar Energy understands that Leavenworth Jefferson EC has filed, or will soon file, an application with the Commission to expand its electric service territory to include the territories described in paragraph 1.
