STATUS UPDATE TO COMPLIANCE AGREEMENT

On July 8, 2021, the Commission issued an *Order Approving Compliance Agreement* (Agreement) in this docket. The Agreement required Operator to bring 57 wells into compliance by bringing three wells into compliance by September 30, 2021, and three wells into compliance per quarter thereafter.¹ On May 5, 2022, the Commission approved the addition of six wells to the agreement and extended the final deadline of the Agreement to September 30, 2026. To date, Operator has brought 38 wells into compliance with the terms of the Agreement. The Agreement provides that it may be amended to include additional wells with the written consent of the District Supervisor.²

The District #3 Supervisor recommends amending this Agreement to include the recently plugged Mann A #OW-1 well, API #15-125-03292 (Subject Well). Operator contacted Staff prior to plugging the well and indicated it is not opposed to the addition of the Subject Well to the Agreement. Further, Staff recommends the final compliance deadline be extended to December 31, 2026.
