PREHEARING OFFICER ORDER
GRANTING MOTION TO WITHDRAW APPLICATION AND CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On January 28, 2019, Slawson Exploration Company, Inc. (Operator) filed an application for an order authorizing the unitization and unit operation of the West Jimmy Unit in Thomas County, Kansas, pursuant to K.S.A. 55-1301, *et seq.*¹ An evidentiary hearing scheduled for May 16, 2019, was cancelled by the agreement of all parties.²

2. On June 11, 2019, Operator filed a motion to withdraw its application. The motion is granted. Based on Operator's withdraw of its application, the Prehearing Officer finds further proceedings are unnecessary. Accordingly, this docket is closed.
