#### ORDER GRANTING SECOND MOTION FOR EXTENSION OF TIME

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

- 1. On August 6, 2024, the Commission directed Vantage Point Solutions ("VPS") to perform an audit of Dialpad, Inc. ("Dialpad") for Kansas Universal Service Fund (KUSF) purposes.
- 2. On February 3, 2025, VPS filed its Audit Report for Dialpad regarding Operating Year 27 (March 2023–February 2024) which recommended, the commission require Dialpad to take corrective actions.
- 3. On February 11, 2025, the Commission's order adopted VPS's February 3, 2025, Audit Report and its recommendations.
- 4. On July 2, 2025, Dialpad filed its second Motion for Extension of Time to comply. Dialpad requests the deadline be extended to 60 days, or to September 1, 2025. VPS's Compliance Report would accordingly be due by October 1, 2025.
- 5. Staff of the Commission do not object to Dialpad's second request for a continuance of time to comply with VPS's Audit Report.

6. K.A.R. 82-1-217(b) grants the Commissions the ability to extend any deadline for good cause. Nothing in the record indicates that Dialpad's request is in bad faith or designed to unnecessarily delay compliance, therefore the Commission grants its Motion for Extension of Time. The Commission extends the deadline for DialPad to correct the deficiencies identified in the Audit Report to September 1, 2025. Additionally, the Commission directs Dialpad to provide periodic updates on its progress to Staff by the fifteenth day of each month. The Commission also

#### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

extends the deadline for VPS to file its compliance report to October 1, 2025.

A. Dialpad, Inc.'s Motion for Extension of Time is granted. The deadline for Dialpad to correct the deficiencies identified in the VPS Audit Report, is extended to September 1, 2025.

B. The deadline for VPS to submit its compliance report is extended to October 1, 2025.

C. Dialpad shall provide periodic, informal written updates on its progress to Staff by the fifteenth day of each month until October 1, 2025.

D. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1). <sup>1</sup>
