Attached for filing with the Commission are revisions to the maps of the Kansas City Metropolitan Exchange and Zone Area (28th Revised Sheet 1), the Bethel Zone Area (7th Revised Sheet 8), the Bethel Zone Base Rate Area (8th Revised Sheet 2), the Bonner Springs Zone Area (17th Revised Sheet 9), the Bonner Springs Base Rate Area (8th Revised Sheet 3) and the Metes and Bounds descriptions of the Bethel Zone (1st Revised Sheet 77) and the Bonner Springs Zone (1st Revised Sheet 78 and 1st Revised Sheet 79) for Southwestern Bell Telephone Company d/b/a AT&T Kansas.





#### METROPOLITAN EXCHANGE AND ZONE AREA MAP





#### ZONE AREA MAP








