ORDER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the

Commission finds the following:

1. On June 27, 2017, the Commission issued a Penalty Order against Benjamin M. Giles (Operator) alleging the Operator violated K.A.R. 82-3-104 and K.A.R. 82-3-111 at the Flying J Geer #2 OWWO, API #15-015-01490-00-01 (Flying J Geer #2), in Butler County, Kansas and assessed the Operator a \$2,600 penalty for the violations.¹

2. On August 1, 2017, the Commission issued a Penalty Order against the Operator alleging violation of K.A.R. 82-3-111 at the Paulsen #1, API #15-015-01020-00-02 (Paulsen #1), in Butler County, Kansas and assessed the Operator a \$100 penalty for the violation.²

3. On September 28, 2017, the Commission issued a Penalty Order against the Operator alleging violation of K.A.R. 82-3-604(a) and (b) at the Ralston Lease Tank Battery in Butler County, Kansas and assessed the Operator a \$500 penalty for the violations.³

4. On October 12, 2017, the Commission issued a Penalty Order against the Operator alleging the Operator violated K.A.R. 82-3-104 and K.A.R. 82-3-111 at the Wright #1 OWWO, API #15-015-01211-00-02 (Wright #1), in Butler County, Kansas and assessed the Operator a \$10,100 penalty for these violations.⁴

5. On October 26, 2017, the Commission issued a Penalty Order against the Operator alleging violation of K.A.R. 82-3-602 at the Wright #1 and assessed the Operator a \$100 penalty for such violation.⁵

6. On October 26, 2017, the Commission issued a Penalty Order against the Operator alleging violation of K.A.R. 82-3-608 at the Wright #1 and assessed the Operator a \$250 penalty for such violation.⁶

7. The Operator filed a timely request for hearing in all dockets.

8. On February 19, 2018, Commission Conservation Division Staff (Staff) moved the Commission, unopposed by the Operator, to consolidate the aforementioned dockets.

9. On March 8, 2018, the Commission granted Staff's motion and consolidated the dockets.

10. On May 17, 2018, the Commission convened the evidentiary hearing.

11. On June 4, 2018, the transcript of the evidentiary hearing was submitted.

12. Pursuant to K.S.A. 77-526(g), the Commission shall render a final order within thirty days of the conclusion of the hearing. However, that the period can be "waived or extended with the written consent of all parties or for good cause shown."⁷

13. The Commission has traditionally considered the hearing to conclude upon the submission of the transcript. Accordingly, a final order in this matter would be due July 4, 2018.

July 4 is a legal holiday. Therefore, a final order would not be due until July 5, 2018.⁸ The Commission finds that the full thirty days allotted is necessary to adequately consider the matter.

14. On January 11, 2018, the Commission approved the 2018 Commission business meeting calendar.⁹ The Commission did not schedule any meetings for the week of July 2, 2018.

15. The Prehearing Officer reached out to the Parties to secure written consent to extend the deadline. The Operator did not object and consented to extending the time period. The Commission finds and concludes that because the Commission will not convene and the Operator has consented, good cause exists to extend the deadline.

THEREFORE, THE COMMISSION ORDERS:

A. The deadline to issue a final order shall be extended until July 10, 2018.

B. This Order constitutes non-final agency action.¹⁰ Any request for review of this action shall be in accordance with K.S.A. 77-608 and K.S.A. 77-613. Lynn M. Retz, Secretary to the Commission, is the proper party to receive service of a petition for judicial review on behalf of the Commission.¹¹

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
