COMES NOW USCOC of Nebraska/Kansas, LLC, d/b/a U.S. Cellular ("U.S. Cellular"), and, pursuant to the State Corporation Commission of the State of Kansas' ("Commission") March 27, 2012 Order Requiring Eligible Telecommunications Carriers to Comply with New Lifeline Requirements and Requesting Comments ("Order") in the above-captioned docket, submits the following Response to paragraph 20 of the Commission's Order.

- 1) **Does your Company continue to satisfy the "own facilities" requirement under amended 47 C.F.R. 54.401(a)?**

Response: Yes.

- 2) **If you response to Question 1 is yes, please provide a detailed explanation of how your Company satisfies the "own facilities" requirement in Kansas, including a listing of the facilities used to provide voice telephony service, a description of the facilities, and location of said facilities.**

Response: U.S. Cellular is a facilities based wireless carrier operating in Kansas. The USCOC network provides wireless services to customers through its own network, including switches in Salina and Joplin and approximately 175 cell sites throughout its service area. USCOC connects its network to the public switched network through various carriers to pass traffic.

WHEREFORE U.S. Cellular submits the above Response in compliance with paragraph 20 of the Commission's Order.
