## MOTION FOR EXTENSION OF TIME

COME NOW Westar Energy, Inc. (Westar North) and Kansas Gas and Electric Company (Westar South) (collectively referred to as "Westar") and move the Kansas Corporation Commission (Commission) for an order extending the time in which comments are due in this matter from January 5, 2007, to February 5, 2007 and Reply Comments are due from February 4, 2007, to March 4, 2007. In support of this motion, Westar states:

- 1. An Order Initiating Investigation and Assessing Costs was filed on November 6, 2006, opening this matter and making all Kansas jurisdictional gas, electric, and water certificated public utilities and the Citizens' Utility Ratepayer Board parties hereto. The order set January 5, 2007, as the deadline for filing Comments and February 4, 2007, as the deadline for filing Reply Comments.
- 2. Because the deadline for filing comments falls immediately after the holidays, Westar requests an additional thirty days to review the issues and file comments so that it can adequately address the questions raised by the Commission in the Order and requests that the time for reply comments also be extended accordingly.


