NOTICE OF PENALTY ASSESSMENT 25-TRAM-293-PEN

This is a notice of a penalty assessment against Rex Rice Harvesting ("Rex Rice") for violations of Kansas Motor Carrier Safety Statutes, Rules, and Regulations discovered during a compliance review conducted on January 17, 2025, by Kansas Corporation Commission Special Investigators. The Special Investigators identified one hundred and six (106) violations of the Motor Carrier Safety regulations. Penalties for the violations are assessed in accordance with the FY 2025 Uniform Penalty Assessment Matrix, approved by the Commission on June 27, 2024. Rex Rice has been assessed a \$4,900.00 penalty. For a full description of the penalties and terms and obligations please refer to the Order attached to this notice.

IF YOU ACCEPT THE PENALTY: You have thirty (30) days from the date of service of the Penalty Order to pay the penalty. Please remit payment of \$4,900.00 through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network ("KTRAN") system located at https://puc.kcc.ks.gov/ktran/. If you have not received a letter from the Transportation Division assigning you a PIN, please contact that Division at 785-271-3145. You must have an account through KTRAN to pay the penalty owed.

The attached Order also requires a representative of Rex Rice:

- a. To attend a Commission-sponsored safety seminar within thirty (30) days from the date of the Order. A schedule of dates and locations for safety seminars can be found at the Commission's website http://www.kcc.state.ks.us/trans/safety_meetings.htm.
- b. To submit a written, comprehensive Corrective Action Plan ("CAP") to Transportation Staff within thirty (30) days of the date of this order, documenting the violations described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violations do not occur in the future.
- c. To submit to one follow-up safety compliance review within eighteen (18) months from the date of this Penalty Order. Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for the review.

IF YOU CONTEST THE PENALTY ORDER: You have the right to request a hearing. A request for a hearing must be made in writing, and within fifteen (15) days from the date of service of this Order, setting forth the specific grounds upon which relief is sought. You may request a hearing through the Commission's electronic filing system found at https://puc.kcc.ks.gov/e-filing/e-express/, and you must also mail a copy of the request for hearing to the undersigned at the above address. If you do not have access to the internet, you can mail an

original and seven copies of the request to the Acting Secretary to the Commission at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy to the undersigned Litigation Counsel.¹

IF YOU FAIL TO ACT: Failure to pay the penalty of \$4,900.00 within thirty (30) days from the date of service of the Penalty Order or failure to comply with the terms of the Order, or in the alternative, failure to provide a timely written request for a hearing, will result in the Order becoming final and may result in additional sanctions of suspension and/or revocation of your motor carrier operating authority.

PENALTY ORDER

The above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission"). Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. Pursuant to K.S.A. 66-1,108b, 66-1,111, 66-1,112 and 66-1,114b, the Commission is given full power, authority, and jurisdiction to supervise and control motor carriers, as defined in 49 C.F.R. Part 390.5 as adopted by K.A.R. 82-4-3f, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority, and jurisdiction.
- 2. Pursuant to K.S.A. 66-129a, 66-1,130, and 66-1,142b, the Commission may suspend operations, revoke or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision, or regulation of the Commission.

- 3. The Commission has the authority, pursuant to K.A.R. 82-1-237, to investigate an entity under the Commission's jurisdiction and issue an order on the Commission's own motion when the Commission believes the entity is in violation of the law or any order of the Commission.
- 4. Rex Rice Harvesting ("Rex Rice" or "Carrier") is a motor carrier as defined in 49 C.F.R. 390.5 and operates under USDOT number 4334228.
- 5. The Commission finds it has jurisdiction over Rex Rice pursuant to K.S.A. 66-1,108b because it is a motor carrier as defined in 49 C.F.R. Part 390.5 as adopted by K.A.R. 82-4-3f.
- 6. On January 17, 2025, a Commission Transportation Staff ("Transportation Staff" or "Staff") Special Investigator ("SI") completed a safety compliance investigation of Rex Rice. As a result of the compliance investigation, the SI identified one hundred and six (106) violations, set forth in four (4) counts of the Motor Carrier Safety Regulations ("MCSRs"), which carry a penalty set forth in the FY2025 Uniform Penalty Assessment Matrix.¹
- 7. On January 27, 2025, Transportation Staff submitted its Report and Recommendation ("R&R"), attached hereto as "Attachment A" and hereby incorporated by reference herein, recommending a penalty of \$4,900.00 to be issued to Rex Rice based on the frequency, timeline, and severity of the violations discovered.
- 8. Specifically, pursuant to Staff's R&R, the Commission finds that Rex Rice committed one hundred and six (106) violations of the following four (4) counts, discussed more fully in Staff's R&R:²

- a. Count 1: On September 11, 2025, Rex Rice required or permitted its driver, Rex Rice, to operate a commercial driver's license required commercial motor vehicle (a 2003 International, VIN ending 4326, GVWR over 33,000 lbs., pulling a 2020 Jett trailer, VIN ending in 0587) in Kansas on a public road (Rossville to Topeka) without having an alcohol and controlled substance testing program, which resulted in one (1) violation of 49 C.F.R. 382.115(a), adopted by K.A.R. 82-4-3c. The Commission finds that Staff's recommendation of a penalty of \$650 is appropriate and in accordance with the current Penalty Matrix.
- b. Count 2: On September 11, 2025, Rex Rice required or permitted its driver, Rex Rice, to operate a commercial driver's license required commercial motor vehicle (a 2003 International, VIN ending 4326, GVWR over 33,000 lbs., pulling a 2020 Jett trailer, VIN ending in 0587) in Kansas on a public road (Rossville to Topeka) without obtaining a valid CDL, which resulted in one (1) violation of 4 K.S.A. 8-2,125, et. seq., K.A.R. 82-4-6a (*See also* K.S.A. 8-2,132 and 49 C.F.R. 392.1, 49 C.F.R. 392.2, adopted by K.A.R. 82-4-3h.). The Commission finds that Staff's recommendation of a penalty of \$500 is appropriate and in accordance with the current Penalty Matrix.
- c. Count 3: On September 11, 2025, Rex Rice required or permitted its driver, Rex Rice, to operate a commercial driver's license required commercial motor vehicle (a 2003 International, VIN ending 4326, GVWR over 33,000 lbs., pulling a 2020 Jett trailer, VIN ending in 0587) in Kansas on a public road (Rossville to Topeka) without first being registered with the Federal Drug and Alcohol Clearinghouse, which resulted in one (1) violation of 49 C.F.R. 382.711, adopted by K.A.R. 82-4-

- 3c. The Commission finds that Staff's recommendation of a penalty of \$750 is appropriate and in accordance with the current Penalty Matrix.
- d. Count 4: On September 11, 2025, Rex Rice required or permitted its driver, Rex Rice, to operate a commercial driver's license required commercial motor vehicle (a 2003 International, VIN ending 4326, GVWR over 33,000 lbs., pulling a 2020 Jett trailer, VIN ending in 0587) in Kansas on a public road (Rossville to Topeka) and load of corn with a gross weight of 93,880 lbs., which is 8,380 lbs. over the statutory weight limit of 85,500 lbs. As more fully set forth in Staff's R&R, the SI found that Rex Rice had hauled one hundred and three loads above the statutory weight limit, resulting in one hundred and three violations of K.S.A. 8-1901(a) and K.S.A. 8-1909, adopted by K.A.R. 82-4-3h.³ The Commission finds that Staff's recommendation of a penalty of \$3,000.00 is appropriate and in accordance with the current Penalty Matrix.
- 9. The Commission hereby adopts Staff's findings as contained in its January 27, 2025, R&R.
- 10. The Commission finds that Rex Rice is required to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within thirty (30) days from the date of this Order. A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety meetings.htm.
- 11. The Commission further finds that Rex Rice is required to submit a written, comprehensive Corrective Action Plan ("CAP") that is satisfactory to Transportation Staff within

thirty (30) days of the date of this order, documenting the violation(s) described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.⁵

- 12. The Commission further finds that Rex Rice is required to submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order at a time agreeable to Staff.⁶
- 13. Failure to comply with the requirements of this Penalty Order shall result in suspension of Rex Rice's motor carrier operating authority without further notice.⁷
- 14. The Commission concludes the penalty of \$4,900.00 for the one violation set forth above, and the additional three requirements set forth in paragraphs 10, 11, and 12 are just and reasonable.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. Rex Rice is hereby assessed a \$4,900.00 civil penalty for one hundred and six (106) violations, set forth in four (4) counts of Kansas law governing the regulation of motor carriers, the Kansas Administrative regulations, and provisions of the Federal Motor Carrier Safety Regulations, as adopted by the Kansas Administrative Regulations.
- B. Rex Rice is hereby ordered to have a representative responsible for the Carrier's safety compliance attend a Commission-sponsored safety seminar within thirty (30) days from the date of this Order.
- C. Rex Rice is hereby ordered to submit a written, comprehensive corrective action plan ("CAP") that is satisfactory to Transportation Staff within thirty (30) days of the date of this

order, documenting the violations described in this Penalty Order, including specific and detailed information explaining Carrier's efforts and concrete steps taken to ensure the violations do not occur in the future.

- D. Rex Rice is ordered to submit to one follow-up safety compliance review within eighteen (18) months from the date of this Order at a time agreeable to Staff.
- E. Pursuant to K.S.A. 77-537 and K.S.A. 77-542, any party may request a hearing on the above issue(s) by submitting a written request setting forth the specific grounds upon which relief is sought. The request may be electronically filed with the Commission's electronic filing system at https://puc.kcc.ks.gov/e-filing/e-express/, within fifteen (15) days from the date of service of this Order, and a copy of the request mailed to the Litigation Division. If you do not have access to the internet, you can mail an original and seven copies of the request to the Acting Secretary to the Commission at 1500 S.W. Arrowhead Road, Topeka, Kansas 66604, and mail a copy of the request to Litigation Counsel. A hearing will be scheduled only upon written request. Failure to timely request a hearing will result in a waiver of Rex Rice's right to a hearing, and this Penalty Order will become a Final Order.
- F. If a request for hearing is filed, attorneys for all parties shall enter their appearances in Commission proceedings by giving their names and addresses for the record. For civil penalties exceeding \$500.00, a corporation shall appear before the Commission by its attorney, unless waived by the Commission for good cause shown and a determination that such waiver is in the public interest.⁸ For civil penalties of \$500.00 or less, a corporation may appear by a duly authorized representative of the corporation.⁹

G. If you do not request a hearing, the payment of the civil penalty of \$4,900.00 is due in thirty (30) days from the date of service of this Order. Payment of \$4,900.00 must be made through your personal account with the Kansas Corporation Commission's Kansas Trucking Regulatory Assistance Network ("KTRAN") system located at https://puc.kcc.ks.gov/ktran/. You must have an account through KTRAN to pay the penalty.

H. Failure of Rex Rice to perform, pay, or fully comply with the provisions of this Order, including but not limited to Ordering Clauses A through D, above, will result in suspension of Rex Rice's motor carrier operating authority without further notice. ¹⁰ Additionally, the Commission may impose further sanctions to include, but not limited to, the issuance and enforcement of revocation of authority and/or cease and desist orders, and any other remedies available to the Commission by law, without further notice.

EXECUTIVE SUMMARY:

Rex Rice Harvesting is a motor carrier (MC) possessing public for-hire operating authority from the Commission, primarily hauling grain, feed and hay. Rex Rice Harvesting operates under USDOT 4334228. On January 17, 2025, a Commission Staff (Staff) Special Investigator (SI) completed a safety compliance investigation of the operations of Rex Rice Harvesting. A copy of the safety compliance report is attached hereto as **Exhibit 1** and is hereby incorporated by reference. As a result of this investigation, the SI identified one hunderd and six (106) violations, set forth in four (4) specific counts, of the Motor Carrier Safety Regulations (MCSRs), which carries a penalty according to the FY2025 Uniform Penalty Assessment Matrix approved by the Commission. Based on the frequency, timeline and severity of the violations discovered by the SI, staff recommends penalty of \$4,900 be issued to the MC.

DISCUSSION AND ANALYSIS:

On January 17, 2025, a Commission Staff SI conducted a safety compliance investigation of the operations of Rex Rice Harvesting. The investigation covers a 365 day period and any previous compliance review. Each specific count is detailed below.

Count One (1 of 4)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: 49 C.F.R. 382.115(a), titled "Starting date for testing programs," states: "(a) All domestic-domiciled employers must implement the requirements of this part on the date the employer begins commercial motor vehicle operations." Specific testing procedures are outlined in 49 C.F.R. 382.105.

Material Facts and Supporting Documents: On September 11, 2024, Rex Rice Harvesting required or permitted its driver, Rex Rice, to operate a commercial driver's license (CDL) required commercial motor vehicle (CMV), a 2003 International, VIN ending 4326, GVWR over 33,000 lbs., pulling a 2020 Jett trailer, VIN ending in 0587, in intrastate commerce from Rossville, Kansas to Topeka, Kansas. This trip is evidenced by a Cargill Elevator scale ticket attached hereto as Exhibit 2. The MC did not provide the SI with evidence of enrollment in an alcohol and controlled substance testing program compliant with 49 C.F.R. 382.115(a) at the time of this transport.

<u>Violation</u>: Rex Rice Harvesting operated a CDL-required CMV without having an alcohol and controlled substance testing program, which is a violation of 49 C.F.R. 382.115(a), adopted by K.A.R. 82-4-3c (Exhibit 1, Page 3). One (1) violation discovered (Exhibit 1, Page 10). <u>Recommendations:</u> Staff recommends a fine of \$650, in accordance with the FY 2025 Penalty Matrix.

Count Two (2 of 4)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: K.A.R. 82-4-6a states: "Each motor carrier and driver shall comply with the following:... (b) the state traffic laws and regulations of the Kansas department of revenue pertaining to driver's licenses as established in the Kansas driver's license act, K.S.A. 8-222 et seq. and amendments thereto;"

49 C.F.R. 392.1 states: "(a) Every motor carrier, its officers, agents, representatives, and employees responsible for the management, maintenance, operation, or driving of commercial motor vehicles, or the hiring, supervising, training, assigning, or dispatching of drivers, shall be instructed in and comply with the rules in this part.

49 C.F.R. 392.2 states: "Every commercial motor vehicle must be operated in accordance with the laws, ordinances, and regulations of the jurisdiction in which it is being operated. However, if a regulation of the Federal Motor Carrier Safety Administration imposes a higher standard of care than that law, ordinance or regulation, the Federal Motor Carrier Safety Administration regulation must be complied with."

K.S.A. 8-2,132. Same; driver of commercial vehicle must have a commercial class driver's license to operate vehicle; violations; penalty

"(a) On and after April 1, 1992, except when driving under a commercial class A, B or C or class A or B instruction permit or a valid class C license and accompanied by the holder of a commercial driver's license valid for the vehicle being driven, no person may drive a commercial motor vehicle unless the person has a valid commercial driver's license and is in immediate possession thereof and applicable endorsements valid for the vehicle they are driving, except that no person charged with violating this subsection shall be convicted if such person produces in court or the office of the arresting officer a commercial driver's license issued to such person and valid at the time of the arrest.

- (b) No person shall drive a commercial motor vehicle while their driving privilege is suspended, revoked or canceled or while subject to a disqualification.
- (c) No person shall drive a commercial motor vehicle in violation of an out-of-service order.
- (d) Any commercial driver in violation of this section shall be guilty of a class B misdemeanor."

Material Facts and Supporting Documents: This violation took place during the transport on September 11, 2024, described in Count One, above. Additionally, this violation is evidenced by the driver's Kansas MVR confirming he does not possess a CDL, attached hereto as Exhibit 3. On the MVR, after "CDL:" the form is blank, indicating the driver did not possess a CDL. Violation: Rex Rice Harvesting utilized a driver without a CDL to operate a CDL-required vehicle, which is a violation of K.S.A. 8-2,132, K.A.R. 82-4-6a (See also K.S.A. 8-2,132 and 49 C.F.R. 392.1, 49 C.F.R. 392.2, adopted by K.A.R. 82-4-3h.) (Exhibit 1, Page 3). One (1) violation was discovered. (Exhibit 2, Pages 10).

Recommendation: Staff recommends a fine of \$500, in accordance with the FY 2025 Penalty

Count Three (3 of 4)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: 49 C.F.R. 382.711 states: "Clearinghouse registration required. Each employer and service agent must register with the Clearinghouse before accessing or reporting information in the Clearinghouse."

Material Facts and Supporting Documents: This violation took place during the transport on September 11, 2024, described in Count One, above. Additionally, this violation is evidenced by a screenshot showing the carrier is not registered in the Federal Drug and Alcohol Clearinghouse (DACH), attached hereto as Exhibit 4. The SI searched for the MC by its USDOT Number and obtained no result.

<u>Violation</u>: Rex Rice Harvesting failed to register in the DACH, which is a violation of 49 C.F.R. 382.711, adopted by K.A.R. 82-4-3c (Exhibit 1, Pages 3 to 4). One (1) violation was discovered. (Exhibit 2, Page 10).

Recommendation: Staff recommends a fine of \$750, in accordance with the FY 2025 Penalty Matrix.

Count Four (4 of 4)

Authority: K.S.A. 66-1,111 and 66-1,129.

Relevant Statutes: K.A.R. 82-4-6a states: "Each motor carrier and driver shall comply with the following:...(c) the uniform act regulating traffic and the size, weight, and load of vehicles as established in K.S.A. 8-1901 et seq. and amendments thereto; and

- (d) the regulations issued by the commission pertaining to the driving of commercial motor vehicles as adopted in K.A.R. 82-4-3h."
- 49 C.F.R. 392.1 states: "(a) Every motor carrier, its officers, agents, representatives, and employees responsible for the management, maintenance, operation, or driving of commercial motor vehicles, or the hiring, supervising, training, assigning, or dispatching of drivers, shall be instructed in and comply with the rules in this part.
- 49 C.F.R. 392.2 states: "Every commercial motor vehicle must be operated in accordance with the laws, ordinances, and regulations of the jurisdiction in which it is being operated. However,

if a regulation of the Federal Motor Carrier Safety Administration imposes a higher standard of care than that law, ordinance or regulation, the Federal Motor Carrier Safety Administration regulation must be complied with."

K.S.A. 8-1901(a) states: "It shall be unlawful for any person to drive or move or for the owner or lessee to cause or knowingly permit to be driven or moved on any highway any vehicle or combination of vehicles of a size or weight exceeding the limitations stated in article 19 of chapter 8 of Kansas Statutes Annotated or otherwise in violation of this article, and the maximum size and weight of vehicles herein specified shall be lawful throughout this state, and local authorities shall have no power or authority to alter such limitations except as express authority may be granted in this article."

K.S.A. 8-1909 describes the specific weight limits.

Material Facts and Supporting Documents: This violation took place during the transport on September 11, 2024, described in Count One, above. During this transport, driver Rex Rice hauled a load of corn with a gross weight of 93,880 lbs. (See Exhibit 2), which is over the maximum weight limit of 85,500 lbs. In total, the SI found that Rex Rice had hauled one hundred and three loads above the statutory weight limit, resulting in one hundred and three violations. Violation: Rex Rice Harvesting operated over the maximum gross weight of 85,500 lbs. allowed in Kansas, which is a violation of K.A.R. 82-4-6a, K.S.A. 8-1909, 49 C.F.R. 392.1 and 49 C.F.R. 392.2, adopted by K.A.R. 82-4-3h (Exhibit 1, Page 4). One hundred and three (103) violations were discovered. (Exhibit 2, Page 10).

Recommendation: Staff recommends a fine of \$3,000, in accordance with the 2025 Penalty Matrix.

RECOMMENDATION:

Transportation Staff recommends the Commission find Rex Rice Harvesting committed one hunderd and six (106) violations, set forth in four (4) specific counts, of Kansas law that governs MCs, including various provisions of the Federal Motor Carrier Safety Regulations (FMCSRs), as adopted by the Kansas Administrative Regulations (K.A.R.s), and is therefore subject to sanctions or fines imposed by the Commission.


Due to the frequency, timeline and severity of the violations, Staff recommends a civil penalty of \$4,900 for one hunderd and six (106) violations of the MC Safety Statutes, Rules and Regulations, in accordance with the recommended penalties listed in the applicable Uniform Penalty Assessment Matrix.

Staff further recommends Rex Rice Harvesting require a representative responsible for the company's safety to attend a Commission-sponsored safety seminar within thirty (30) days from the date of the Order, and provide Litigation Counsel with written proof of attendance. A schedule of the dates and locations for safety seminars can be found on the Commission's website at http://kcc.ks.gov/trans/safety_meetings.htm.

Staff further recommends Rex Rice Harvesting submit a written, comprehensive Corrective Action Plan (CAP) to Transportation Staff within thirty (30) days of the date of this order, documenting the violation(s) described in the Penalty Order, including specific and detailed

information explaining the carrier's efforts and concrete steps taken to ensure the violation(s) do not occur in the future.

Finally, Staff recommends that Rex Rice Harvesting submit to one follow-up safety compliance review within eighteen (18) months from the date of the Penalty Order. Transportation Staff will contact the motor carrier at a later date to determine an appropriate time for the review.
