JOINT MOTION FOR PROCEDURAL SCHEDULE

Atmos Energy Corporation (Atmos), Black Hills/Kansas Gas Utility Company, LLC, d/b/a Black Hills Energy (Black Hills Energy), the Citizens' Utility Ratepayer Board (CURB), Kansas Gas Service, a Division of ONE Gas, Inc. (Kansas Gas Service), Kansas City Power & Light Company (KCP&L) and Westar Energy, Inc. and Kansas Gas and Electric Company (referred to together herein as Westar), the Staff of the State Corporation Commission of the State of Kansas (Staff and Commissioner, respectively), and the Wichita Area Builders Association, Inc. (WABA) (all parties collectively referred to as Joint Movants) hereby move the Commission for an order establishing a procedural schedule in this matter. In support of thereof, Joint Movants state the following:

1. On January 8, 2019, the Commission issued its *Order Opening General Investigation* (Order) "to evaluate allowing electric and gas utilities the authority to accept ILOCs [irrevocable letters of credit] in lieu of cash deposits for system expansion related to residential developments."¹ The Order was in response to a Staff Report and Recommendation (Report) filed in Docket No. 18-WSEE-163-TAR (18-163 Docket), wherein Staff recommended

the Commission initiate this general investigation and direct Kansas electric and gas utilities to respond to a series of twenty-one questions relating to ILOCs. As part of its Order, the Commission made all Kansas gas and electric public utilities a party to the proceeding, set the deadline for entries of appearance as January 30, 2019, and restated the questions posited by Staff to be addressed as part of this investigation.²

2. Joint Movants include all interested parties who filed entries of appearance on or before the January 30, 2019 deadline.

3. Joint Movants worked collaboratively to develop the following proposed procedural schedule to govern this proceeding.
